



## COVID-19 Student-Safe Travel, Arrival and Quarantine Checklist

The first priority of Coquitlam College is the health and safety of our students. We are also obligated to follow the regulations and recommendations of various authorities, including the Government of Canada, provincial and local public health authorities.

The Government of Canada has put in place an emergency order under the Quarantine Act. It applies to all travellers arriving in Canada. Its purpose is to slow the spread of COVID-19 in Canada. Failure to comply with this order is an offence under the Quarantine Act.

**Please confirm that that you understand and agree with the following by checking each box and signing below:**

- I agree to comply with the requirements laid out in the Coquitlam College International Student Safe Travel, Arrival and Self-Isolation Guide, including the self-isolation guidelines as outlined by the Public Health Agency of Canada.
- I have completed and printed the Coquitlam College Self-Isolation Plan Form and provided a signed copy to Coquitlam College and will print a copy for presentation at my port of entry, and have downloaded and registered via both the BC self-isolation plan AND the ArriveCAN App, mandatory as of Nov. 20, 2020.
- I confirm that I have private medical insurance coverage for COVID-19 during the quarantine period
- I have completed and printed the Coquitlam College Self-Isolation Plan Form and provided a signed copy to Coquitlam College and will print a copy for presentation at my port of entry.
- I have downloaded and registered via both the BC self-isolation plan AND the ArriveCAN App
- I confirm that I have booked my initial 3-night hotel stay prior to my departure to Canada as well as an adequate place of quarantine for the following 11 nights.
- I confirm that I have proof of a negative COVID test taken within 72 hours before travelling to Canada.
- I am aware that when I arrive at the port of entry, I must show my valid LOA and valid study permit
- I am aware that when I arrive at the port of entry to Canada, I will take another COVID-19 molecular test when I arrive in Canada before exiting the airport, and a third one on day 10 of my 14-day quarantine period.
- I am aware of the requirement to comply with the Government of Canada's Quarantine Act, including the penalties of violation of the Quarantine Act, which include up to 6 months in prison and/or \$750,000 in fines.

I confirm that I understand the importance of the quarantine/self-isolation procedure upon arrival in Canada, and will follow all criteria provided requirements provided by the Government of Canada, for a full 14 days after my arrival in Canada.

I understand that failure to meet these requirements may result in being denied entry to Canada, or having to carry out quarantine in a government-approved facility
